INTRODUCTION

FORMATION AND STATUS

The Alcohol Policy Alliance - Ghana (GhanAPA) is an amalgamation of independent Civil Society Organizations (CSOs) working towards advancing a healthy nation through policy development and advocacy with the vision of contributing to the elimination of alcohol related harms in Ghana. GhanAPA was started in 2018 by four Civil Society Organizations (CSOs) and has expanded over the years and currently has a membership of twelve active independent CSOs. GhanAPA became a legal body with a Constitution in December 2018 and is registered with the Registrar Generals' Department with Certificate number CG0739922019 in May 2019. The member CSOs are; Institute of Leadership and Development (INSLA), Action for Integrated Development (AID), Aid for Needy Children Foundation (ANCF), Federation of Youth Clubs (FYC), and Vision for Alternative Development (VALD). The rest are Community Focus Foundation Ghana (CFF – Ghana), Federation of Zongo Ladies (FZL), Mothers' Clubs in Development (MCD), Ghana Blue Cross (GBC), and El-Yahweh Club.

The impacts of Alcohol Harm on reducing Sustainable Development Goals (SDGs): A call on stakeholders to swiftly Pass Alcohol Control Legislative Instrument in Ghana in 2023.

- 1. The World Health Organisation (WHO) has set aside the 2nd of October each year as, "World No Alcohol Day." As the name suggests, this day is set aside to spread awareness of the negative effects of alcohol harm on society globally. Excessive drinking potentially leads to violence, irresponsible behavior and driving, causing accidents and injuries. According to WHO, the harmful use of alcohol is responsible for 3.3 million deaths annually throughout the world. This means that for every 10 seconds a human being dies from alcohol harm. This high number of deaths represents 5.9 % of all deaths globally. Additionally, the WHO further states that, the regular consumption of alcohol is linked to high blood pressure, liver diseases, strokes, and diverse types of cancers.
- 2. The WHO in its research has stated that, through its multiple public health, social and economic impacts, alcohol is a major obstacle to achieving as many as 12 out of the 17 Sustainable Development Goals (SDGs) set aside by the United Nations. These are:
- i. Eradicating poverty
- ii. Ending hunger
- iii. Ensuring healthy lives for all
- iv. Ensuring quality education
- v. Achieving gender equality
- vi. Ensuring sustainable management of water resources
- vii. Promoting inclusive, sustainable economic growth
- viii. Reducing inequalities
- ix. Making cities and human settlements safe and inclusive
- x. Ensuring sustainable consumption
- xi. Promotion of peaceful and inclusive societies
- xii. Strengthening means of implementation of the SDGs

The Alcohol Policy Alliance – Ghana wishes to make a clarion Call for Action for our fellow Civil Society Actors to press home our common agenda and demand from our Government to minimize the impact of Alcohol harm on Ghanaians through a swift passage of the Legislative Instrument on Alcohol Control by end of 2023.

The impacts of Alcohol Harm on the Growth and Welfare of Young Adults: A call on stakeholders to swiftly pass the Draft Alcohol Control Legislative Instrument 2023.

Introduction of GhanAPA

The Alcohol Policy Alliance – Ghana, in short form, GhanAPA was formed in 2019 by an amalgamation of ten (10) Civil Society Organisations (CSOs) working towards advancing a Vision of a Healthy Nation through policy development and advocacy and has a Mission of

Contributing to the elimination of Alcohol related harms in Ghana. The GhanAPA institutional membership now stands at twelve (12) independent CSOs,

Alcoholism

Addiction to alcohol, or alcoholism, when diagnosed is called Alcohol Use Disorder (AUD). Alcohol is a psycho-active, **toxic and dependence-producing** substance. According to the World Health Organisation (WHO), No level of Alcohol consumption is safe for human Health.

Alcohol effects in young person

To regulate the hours, days and intensity of alcohol outlets and raising the national legal age limit for drinking and consuming alcohol is another effective strategy used to reduce alcohol use and harm. Currently in Ghana the national legal minimum age for consumption 18 years. However, the WHO has stated that the recommended minimum age should be 25 years as research has found out that young adults below 25 years are still developing their learning, memory and mental capacities, including dementia and poor school performance.

Alcohol addiction impacts the younger generation of below the minimum age of 25 years for Alcohol use with the following harms including high blood pressure, heart disease, stroke, liver disease, and digestive problems. Others are cancer of the breast, mouth, throat, esophagus, voice box, liver, colon, rectum and weakening of the immune system. Further, the WHO says that young adults should not drink alcohol to prevent physical and mental health problems, including alcohol use disorders. Further brain development continues into young adulthood. Teens and young adults don't have the skills or the brain functioning to make the best choices. They might struggle with emotional regulation and impulse control. Alcohol impairs these areas of the brain even further.

Alcohol and Substance Abuse

The brain's reward system helps you learn new skills by releasing "feel good" chemicals to reinforce certain behaviors. Drinking alcohol hijacks this reward system as a shortcut to these chemicals. Young adults are still learning valuable life skills and coping mechanisms. They might be dealing with stressors for the first time. When you drink as a teen or young adult, you might misuse alcohol as a way to feel good when stressed or upset.

Risk factors for alcohol abuse in young people include:

- a. Traumatic experiences
- b. Sexual or physical abuse
- c. Underlying mental health issues, like depression or anxiety
- d. Parents or other close family members who have substance use disorders
- e. Mixing alcohol with other substances, like illicit or prescription drugs
- f. Parents and adults in the community with relaxed views on drinking
- g. Learning disabilities, like attention-deficit/hyperactivity disorder (ADHD)
- h. College students are more likely to drink than young adults not enrolled in college
- i. Young adults in the military are also more likely to have a drinking problem
- j. Young men are more likely to drink than women

Additionally, consuming too much alcohol can affect your health in the long-term. Some side effects may lay dormant for years before they surface. Because of this, professional medical care is required for proper diagnosis and treatment.

Recommendation

With the advent of Christmas festivities which is normally characterized by high alcohol consumption at a single or multiple sittings with high vehicular crashes and high fatalities is highly dangerous for our society. For highway drivers and trotro operators, it increases the risk of over-speeding, blurry vision, poor judgement leading to severe crashes resulting in avoidable deaths, amputations and loss of ability to cater for families.

The Alcohol Policy Alliance – Ghana, GhanAPA is making a desperate call to all caring and responsible Ghanaians to heed to our warning and avoid Alcohol for good.

Finally, Ghan APA is through this *Press Release* calling on the Minister of Health, the Attorney-General and the Parliament of Ghana to swiftly pass the Alcohol Control Legislative Instrument in Ghana in 2023 to save many innocent Live, especially young persons below 25 years.

A roll call was first carried by the Coordinator; Sulley Sumani to ensure a quorum has been achieved. Eight Organisation responded by registering on the Participants Registration Form and also standing and answering to their names being called. The rest join the meeting later

Opening

When the Coordinator reported to the plenary that a quorum was achieved, the Chair declared the meeting opened at 10:20 am and Solomon Foli said the opening prayer. The Chair called on the Coordinator to deliver his welcome address.

Welcome Addresses

The welcome address to all participants to the Annual AGM was read by the National Coordinator.

2. A special welcome was also extended to the Ghana Blue Cross that has been invited by GhanAPA to the AGM to see if the Blue Cross could join the Alliance as the Organisation is known to be in Alcohol issues for a much longer period since as the Coordinator puts since the 1990s. He said the West Africa Alcohol Policy Alliance (WAAPA) Coordinator will give a detail briefing on our invitation to the Blue Cross to partner with us because their experience.

The Chair then asked Mr. Issah Ali, the WAAPA Coordinator, to elaborate on the recommendation from our international partners to form a strong partnership with the Ghana Blue Cross. In his response Mr. Issah Ali gave a detail account about how the blue Cross has joined or about joining National Alcohol Policy Alliances in the sub-region including Burkina Faso, Chad, Nigeria and other countries. After Issah's lecture the Chairman asked that we need to admit Ghana Blue Cross into our Alliance and if there is any member who is against should raise his hand. Abdul Fatah raised his hand and supported. Foli said after Issah's talk he is okay. Chairman said from now we have admitted into the GhanAPA. He said blue cross is joining as a strategic partner/member and we could partner them with our resources.

Issah said at the regional level WAAPA will start issuing membership Certificates to institutional members.

Presentation of Previous minutes of 2022

The Chair asked members to go through the Minutes of 2022 AGM and after that asked for corrections of the minutes page by page.

Corrections and Matters Arising from Previous Minutes

- 1. Issah said the registration of participants should be by member Organizations and not names of individuals
- 2. Foli was next to asked about Kasu was requesting for admitting members from outside the national capital to the regions.

- 3. The WAAPA Coordinator said the current funds from the donor was meant to cover advocacy for policy development and which is centered in the national capital but can is not enough to go the regions to cover community implementation. He advised that we widened our fund raising effort to rake in funds so that we could extend our membership drive into the regions out of Accra
- 4. Fatah moved for the acceptance the previous minutes and was seconded by Mr. Sulley Sumani. The minutes were then adopted.

Presentation of 2022 Annual Report

The Chair said in the middle of 2022 due to some challenges the previous Coordinator resigned and was replaced by Mr. Sulley who was then an Adviser to the Board. The Chairman also said as he was privy to all the issues and so he produced the 2022 Annual Report but from now on the new Coordinator shall produce the 2023 Annual Report.

The Chair said the main challenge during the year was the resignation of the legal officer at the Ministry of Health (MoH) in 2022. The lawyer who was involved in drafting of the LI left and was replaced by a new lawyer, Alhaji Inua in 2022 and who abandoned the previous work done on the LI and started a new draft all over again. Issah said the Deputy Minister of Health Alhaji Seini was invited to the WAAPA Accra Conference and he honored the invitation and gracefully launched the WAAPA 5-year Strategic Development Plan. He said it was the Baraka Institute that started funding the development of the LI but when it funds became exhausted; WAAPA through GhanAPA took over before the Ghana Non-Communicable Diseases (GhNCDA) continued funding the development of the LI. So WAAPA advised GhanAPA not to continue funding as it would amount to duplication of resources.

Adoption of the Report: Nafisa moved for the acceptance of the Report and was seconded by Lilian.

Restructuring of GhanAPA Administration

On the above, the Chairman said that during the resignation of Abdul-Fatah Adam as the National Coordinator, Alhaji Sulley Sumani was brought in as a replacement. The Chair said currently, there were only 3 active Board members; namely the Chair, the National Coordinator and the Treasurer. So he asked the AGM to make replace and confirm the new National Coordinator; Alhaji Sulley Sumani. He further suggested the AGM increase the number of Board members to seven (7) or maintain the five (5). Alhaji Sulley Sumani suggested that with dwindling funds of twelve (12) active member Organizations it was not prudent to increase the number to 7 and therefore suggested the maintenance of five (5). A vote was taken and it was unanimously agreed to replace the two (2) inactive members. The Chair strongly suggested the addition of one female for gender considerations. Hajia Mariam nominated Nafisa and Nafisa

also nominated Hajia Mariam. Upon further discussions and the fact that both nominees declined the nominations due to one reason or another, Nafisa was finally elected unanimously by 10 votes in favour and none against. Richard Kasu was also nominated by Abdul Fatah Adam and vote was also 10 in support and none against. In summary, Alhaji Sulley Sumani, Michael Nartey and Nafisa Ibrahim were unanimously voted and confirmed to replace Abdul Fatah Adam, Labra Masawudu Musah and Amanobia Dodoo.

Presentation of 2023 Program of Work/Plan of Action

The Coordinator was asked by the Chair to take participant through the 2023 PoW which is for a period of 6 months (July to December 2023).

Remarks/Discussions

After its reading Issah said it was not in conformity with the standard format for PoW, which is supposed to be in a Logical Framework. The Coordinator agreed to make the changes. Abdul-Fatah said the previous Plans were in conformity and we should check on that. That was also acknowledged.

Presentation and Discussions on the Final Draft Alcohol Legislation Instrument (LI)

The WAAPA Coordinator took participants through the entire draft LI and highlighted on some salient points which he thinks participants should study, research so that when we meet the Parliamentary Select Committees for Health and of Subsidiary Legislation we will make suggestions for amendments before the LI is laid in Parliament.

Next Steps

Following discussions, participants agreed that the GhanAPA should engage the Ghana Blue Cross and request for funds to hold a one-day workshop for participants. The workshop will give ample time to make discussions of the draft LI to enable GhanAPA make meaningful contributions to the LI hearing during engagements with the lawmakers.

Way Forward

The Chair said we would prepare an Advocacy Flier on the GhanAPA to share with the lawmakers when we engage members of the two Sub-committees of Parliament to make inputs into the final drafts of the LI.

Request for Community Counseling Services

A member Hajia Mariam narrated a pathetic situation of 3 brothers in her community who have alcohol addiction challenges and are completely a societal burden need serious rehabilitation. Hajia Mariam made a passionate appeal to the Blue Cross representative to seek support from the Organization in rehabilitating the trio. In answer, the Blue Cross said to will consider the appeal

and see how they will train about 2 volunteers in Hajia Mariam's community to help in the therapeutic treatment process to reduce cost of transportation from Mamobi to Gbawe.

Group Photograph

A group photograph of the participants was taken and which is at the top of this report.

Closing
